Introduction

Between the years of 1850 and 1868, almost Ten Thousand Convicts were transported to Western Australia, aboard Forty-three Vessels.

By order of the Home Government, the Surgeon Superintendent on board each vessel was required to keep an accurate account of all events which took place during the voyage.

This, the Journal of William Crawford M.D., Staff Surgeon R.N., Surgeon Superintendent, records the events which took place each day on board the Convict Ship "Clyde", which, with its most valuable cargo of Male Convicts, made passage from England to Western Australia in the year of 1863.

When reading this transcript, it is important to note that:-

- (i) Convict Numbers recorded herein, are numbers issued for use in the English Prison System They should not be confused with that number issued to Convicts upon their arrival in Western Australia.
- (ii) Page numbers provided herein, bear no relationship to the original Journal They have been put in place purely to allow indexing. A prepared index showing the names of all persons mentioned in the text can be found on the following page.
- (iii) The List of Convicts contained in pages 38 45 inc., does not form a part of the original Journal It has been compiled from Assignment Lists found on Microfilm (A.J.C.P. Reel 93. 1st Floor Alexander Library).
- (iv) The List of Pensioner Guards contained in pages 46 47 inc., does not form a part of the original Journal This has been compiled from Pensioner Pay Lists found on Microfilm (A.J.C.P. Reel 3918 Battye Library).
- (v) The List of Warders contained on page 47, does not form a part of the original Journal This has been compiled from various sources, including the publication Warders & Gaolers: A Dictionary of Western Australian Prison Officers, 1829 1879 Compiled by Mr. David Barker.
- (vi) When undertaking Transcription from Microfilm, some words proved extremely difficult to read. Missing words are entered thus ...?...

RULES AND REGULATIONS

- No: 1 The Prisoners must conduct themselves in a respectful and becoming manner to all the Officers on board & they are strictly to obey such orders as I may issue through the Captain of Divisions & Heads of Messes.
- No: 2 The Prisoners must behave themselves in a decent & becoming manner at all but more especially when Prayers are read or Divine Service performed. Prayers morning and evening weather permitting.
- No: 3 Cursing and all foul language, shouting, quarrelling, fighting, selling, exchanging or giving away clothes are strictly prohibited.
- No: 4 Any person stealing or secreting any of the Mess Stores or any article belonging to the Mess or the Ship will be severely punished.
- No: 5 Prisoners are on no occasion to hold conversation with the Guard or Ship's Company or talk through the bars below.
- No: 6 Each Mess shall have a Captain and it will be the duty of each man in his turn to clean the Utensils, the latter after each meal are to be taken on Deck & thoroughly cleansed before being passed below. The members of each Mess must sit together.
- No: 7 The Captains of Messes are warned that they will be held responsible for the good order & cleanliness of the Messes, they are to see that the men wash themselves every morning & that they attend to them and that there are no stragglers at night & no one sleeping with his clothes on.
- No: 8 Smoking or striking lights below in the Prison, washing clothes or attempting to dry them, will not be allowed on any pretence whatsoever.
- No: 9 The Captains of Messes will receive their provisions in the order of their Messes, they are to tally their pieces of meat & deliver them to the Cooks, they are also receive Water for their Messes.
- No: 10 Two Inspectors in rotation will be appointed, who will superintend the issue of provisions. A printed copy of the established rations of provisions will be hung up and should they appear of bad quality or deficient in weight they are to submit them for examination to me before they pass the Quarter Deck, after that it will too late to complain.
- No: 11 The night watch will be set at 8 o'clock and they will be held responsible for the peace & good order of the Prison during the night, and it will be their duty to see that no more than one person at a time is in the Water Closet. Prisoners are warned that if found congregating at the bottom of the ladder leading to the Water Closet, they will be punished. Should anything unusual occur, they immediately to report to the Sentry at the Gate.

- No: 12 The bedding is to be taken on Deck every morning when the weather will permit. The Captains of Divisions are to see the beds neatly rolled up by 5.30 A.M. after which they are to be handed through the Prison gate to the Upper Deck Crew to stowed by them & when they are ordered down, they are to be received from the same party.
- No: 13 If at any time a Prisoner has reason to complain of provoking language or treatment from the Ships Company or Guard he is hereby strictly enjoined not to retaliate, but to make the same known to me that the complaint may be investigated.
- No: 14 Each Captain of a Division will have charge of a certain number of Messes, he is to attend to every man in his Division and see that the Prisoners are clean and orderly. The Captains are to attend to the cleanliness of the Prison & check that any impropriety they may witness & to report to me everything they may affect the discipline of the Ship.
- No: 15 The Surgeon Superintendent has to impress upon the minds of the Men that their future prosperity and happiness will depend on their good conduct on board and the report he shall have to make to the Governor of the Colony on arrival.

DAILY & WEEKLY ROUTINE

MONDAY

- 4.30 Prisoner Cooks, (3 in number), admitted on Deck.
- 5.30 Captains of Divisions and Upper deck Crew for the purpose of filling washing tubs &c. Prisoners
- at the same time to commence lashing up their beds & hammocks.
- 6.00 One half the Prisoners admitted for the purpose of washing their persons under the supervision of their respective Captains, half an hour being allowed for this purpose.
- 7.30 Down all Prisoners, Ships Company to commence washing upper deck & Water Closets.
- 8.00 Breakfast.
- 8.30 One man from each Mess admitted on deck for the purpose of washing up their Mess utensils.
- 9.00 All the Prisoners admitted on deck with the exception of two men from each Mess who in rotation will clean and scrape dry the Prison Deck and their berths, the bottom boards of the latter being removed, during which time I will attend in the Surgery & see Sick.
- 9.30 Prison inspected after which all the Prisoners will be assembled for Prayers.
- 10.00 One half of the Prisoners sent on deck for exercise, the other half being arranged in Schools under the Superintendence of the Religious Instructor assisted by Monitors.
- 11.30 Schools to break up. Captains & Inspectors of Provisions to be present at the Issue of Lime Juice at Noon.
- 12 Noon. Dinner.
- 12.30 From each Mess one man to be admitted on deck for the purpose of washing Mess utensils.
- 1.20 Deck to be swept up.
- 1.30 Half the Prisoners admitted on deck, those remaining below being arranged in Schools as in the forenoon.
- 3.30 Schools break up for the day.
- 4.00 Down all beds and Hammocks.
- 4.30 Supper.
- 5.00 One man from each Mess admitted on Deck to wash Mess Utensils.
- 6.30 Prayers.
- 7.00 Petty Officers of the day and night mustered on Deck.
- 8.00 Down all Prisoners.
- 8.30 Rounds.

TUESDAY The same as Monday and all Prisoners to be shaved. Captains of Divisions to see this order carried out.

WEDNESDAY The same as Monday and those Prisoners whose turn it is to be on deck in the forenoon to wash their clothes one man in each Mess delivering the same to the Captains of the Upper Deck Crew.

THURSDAY The same as Wednesday and remaining half of Prisoners to wash their clothes.

FRIDAY The same as Monday.

SATURDAY Schools suspended. Bottom Boards to be scrubbed and dried on Deck. All Prisoners to be shaved.

SUNDAY Divine Service at 10.30. Prisoners professing the Roman Catholic Faith will have one of their members appointed to read Prayers to them. It is expected that all will assemble together in a clean and orderly manner for the Worship of Almighty God.

Mr. Irwin and Mr. Rosser, Religious Instructors joined from Milbank Prison.

Soon after that I went below to the cuddy and found Mr. Bothell, the said Chief Officer, in conversation with Mr. Rosser, the Religious Instructor, commenting on the way in which Mrs. Lane had insulted the Surgeon Superintendent. During the past week, the noise & altercation which has been going on between her children & her two sons has been most difficult to put up with. Her husband informs me that he has no control over her whatever and she puts all authority of defiance. I have given orders to the Guard that Mrs. Lane is not to be allowed on the Poop again.

3 P.M. In consequence of Mrs. Lanes boisterous conduct & her continuing to quarrel with her children, the Surgeon Superintendent has thought fit, as there is no sickness in the Ship or signs of the same, to remove Warder Lane, his wife & family into the Military Hospital, which accommodation is far superior to that which they occupied before & at the same time to have the accommodation under the Poop reserved for the Guard in the event of sickness &c.

In consequence of the apparent severity of the weather, which may continue in these Latitudes, I have to request you will carry sails with moderation & discretion, as a large press of canvas immerses a ship & causes her to take in volumes of water, consequently saturating bedding &c, thereby causing disease to occur amongst large masses of people, whose health I am responsible for & to which Her Majesty's Government look to me to have carried out. By taking a little precaution of this in earnest, it may prevent a vessel of this kind having to call at the Cape & land her living cargo with credit which will be not only for the sake of humanity, but also for the benefit of your (seamen?).

I then told him I would permit him to wear it on his signing a document in the Government Journal, for the information of the Commandant, on arrival at Fremantle.
